**1. MOONWALK(S) &/OR EQUIPMENT(S), RENT AND TERM RENTAL AGREEMENT:** The undersigned, as Lessee (customer), hires from GBAIX Moonwalks and Party Rentals LLC, as Lessor (company),

Moonwalk(s) &/or Equipment(s) unit, identification number or name of Moonwalk(s) & /or Equipment(s): \_\_\_\_\_ The Rental Fee as stated above requires ½ the rental fee to hold the moonwalk(s) and/or equipment(s) for your event at the time of reservation with the rest of rental fee to be paid full within two weeks in advance from the time of commencement. A cleaning fee of \$50.00 per moonwalk(s) &/ or equipment(s) will be charged if moonwalk(s) &/or equipment(s) requires any cleaning beyond what is reasonable (Examples are Gum, Candy, Soft Drinks, Water Balloons, etc)

**2. DELIVERY:** The moonwalk(s) or/and equipment will be delivered to the street address as specified above by the lessee. The lessee grants GBAIX Moonwalks and Party Rentals LLC the right to enter the property at the said street address ("Delivery Address") for the delivery and subsequent pick up of the moonwalk(s) &/or equipment(s) at the specified time.

**3. TRANSPORTATION EXPENSE:** GBAIX Moonwalks and Party Rentals LLC includes delivering and subsequent pick up of the moonwalk(s) &/or equipment(s) with respect to the delivery address are included in the rental within 20 miles of the business. An extra fee will be charged if over 20 miles at a rate of \$2.00 a mile. In the event that the moonwalk(s) &/or equipment(s) is not timely surrendered by lessee to lessor, a \$50.00 extra transportation fee shall be automatically imposed.

**4. GENERAL RULES TO FOLLOW DURING USE OF THE MOONWALK(S):**

**A. ONLY COMPATIBLE AGE GROUPS AND SIZE SHALL PLAY ON THE MOONWALK(S) AT THE SAME TIME. THE MAXIMUM NUMBER OF RIDERS OF EACH GROUP THAT SHOULD PLAY IN THE MOONWALK(S) UNIT AT ONE TIME IS (Not to exceed to recommended amount below)**

**G. DO NOT MOVE THE MOONWALK(S) &/OR EQUIPMENT(S) FROM THE PLACE WHERE IT WAS DELIVERED & INSTALLED. ABSOLUTELY, KEEP THE MOONWALK(S) UNIT AWAY FROM SWIMMING POOLS, WIRES.**

**5. SPECIAL INSTRUCTIONS: Moonwalk(s) equipment is reliable, however, should the MOONWALK(S) begin to deflate First: Remove everyone from the moonwalk(s): (1) the motor has stopped; in which case check the cord connection at the outlet near the motor and remember to keep only the 100 foot extension cord on the outlet. [Stronger outlets are in the kitchen and laundry rooms] (2) If the motor is continuing to run, check the air intake on the side of the motor for blockage and check both tubes at the back of the moonwalks(s) for snugness; retie if necessary. LESSEE AGREES TO PAY LESSOR, ON RETURN OF THE MOONWALK(S) &/OR EQUIPMENT(S) FOR ALL CHARGES INCIDENTAL TO BREAKAGE OR DAMAGE, ORDINARY WEAR EXCEPTED TO THE MOONWALK(S) &/OR EQUIPMENT(S) DURING THE TERM OF THIS RENTAL AGREEMENT. BY INITIALING TO THE LEFT, THE LESSEE AGREES TO THIS PROVISION.**

**7. MAINTENANCE: Lessee agrees to keep the Moonwalk(s) &/or Equipment(s) in the same condition as when received, ordinary wear excepted.**

**8. ALTERATIONS AND ATTACHMENTS: No alterations in or attachments to the Moonwalk(s) &/or Equipment(s) unit will be made without prior written approval of GBAIX Moonwalks and Party Rentals LLC.**

**9. WARRANTY: GBAIX Moonwalks and Party Rentals LLC warrants that the moonwalk(S) &/or equipment(s) leased under this Rental Agreement will be in good working order on the effective date of the Rental Agreement. The Moonwalk(s) &/or Equipment(s) is supplied and maintained subject to this warranty. Lessor's obligation under this rental Agreement is limited to repair or replacement of the Moonwalk(s) &/or Equipment(s) when Lessor determines that it does not conform to this warranty. This warranty is in lieu of any and all other warranties expressed or implied, and of any and all obligations and of any and all liabilities on the part of the Lessor for damages, including, but not limited to, consequential damages, arising out of or in connection with the use or performance of the MOONWALK unit.**
